Motion by Fuxa, second by Gunderson, to approve and file financial statements dated September 30, 2002.

Motion by Gunderson, second by Fuxa, to approve Change Order #1 with Triple D Contracting, Inc. for removal of foundation walls of the portable classrooms at the old elementary school site and backfill at a cost of \$1,910.

Administrative reports were heard.

Motion by Fuxa, second by Gunderson, to allow facility usage after 1:00 pm on Sundays at the discretion of administration.

Motion by Fuxa, second by Markve, to authorize hiring an additional 0.8 FTE Pre-School Educational Assistant effective immediately.
