The Special September 15, 2003 meeting of the Dakota Valley Board of Education was called to order by Chairperson Fuxa at 7:00 pm. Board Members Fuxa, Lochner, Meland and Sexton were present. Gunderson was absent. Administrators Leber, Ashmore and Bietz were also in attendance along with Finance Committee Members M. Cranny, M. Huber, T. Meyer and B. Odson of the *Leader-Courier*.

Supt. Leber led the Pledge of Allegiance.

Motion by Lochner, second by Sexton, to approve the agenda with additions.

Superintendent Leber and Business Manager Bietz presented the proposed 2003-04 Budgets for all school district funds.

Administrator Rasmussen joined the meeting at 7:40 pm.

M. Cranny & T. Meyer left the meeting at 8:10 pm.

Chairperson Fuxa called the general business portion of the meeting to order at 8:10 pm.

Motion by Lochner, second by Meland, to accept a donation of \$1,286.69 from the Southern Union County Action Group for the school library. The board wished to thank this organization for their generous donation.

Motion by Lochner, second by Sexton, to approve the petition for school district residency under SDCL 13-28-10 of a minor child living with a non-custodial guardian.

Motion by Meland, second by Lochner, to approve Pay Application #1 from Brower Construction Co. in the amount of \$47,500 (requested \$48,795.67) for the parking lot addition at the elementary school. Motion by Lochner, second by Meland, to approve landscaping projects at the elementary school by Country Estates Landscaping. Ayes – none, Nayes – unanimous. <u>Motion failed</u>. The board directed Leber to complete the projects through the architects and L&L Builders rather than directly through the contractor.

Leber led discussion of various capital projects plans and priorities.

Administrators Clements and Halverson joined the meeting at 8:30 pm.

Motion by Sexton, second by Meland, to approve and duly resolve adoption of the annual school budgets and tax levy requests:

Let it be resolved, that the School Board of the Dakota Valley School District #61-8, after duly considering the proposed budget and its changes thereto, to be published in accordance with SDCL 13-11-2, hereby approves and adopts its proposed budget and changes thereto, to be its Annual Budget for the fiscal year July 1, 2003 through June 30, 2004. The adopted Annual Budget Revenue / Expenditure totals are as follows: General Fund - \$4,514,308; Capital Outlay - \$440,150; Special Education - \$672,331; Pension Fund - \$90,000; HS Bond Redemption Fund - \$631,827; ES Bond Redemption Fund - \$489,379; Capital Projects Fund - \$49,000; Food Service - \$378,000.
